Important note:

Students can take ATO exams as outlined in previous page of this Instruction/ Plan for taking ATO exams.

After passing each semester of FPZ study programme, student reports to FPZ-HZNS CTKI, who supervises the procedure of taking ATO exams, and proves his/her attendance by bringing his/her index book with signatures in relevant subjects, which allows him/her to take ATO exam.

Responsibilities of the students/applicants (according to FCL.025 Theoretical knowledge examinations for the issue of licences and ratings):

- (1) Students/applicants shall take the entire set of theoretical knowledge examinations for a specific licence or rating under the responsibility of one Member State;*
- (2) Students/applicants shall only take the theoretical knowledge examination when recommended by the approved training organization (ATO) responsible for their training, once they have completed the appropriate elements of the training course of theoretical knowledge instruction to a satisfactory standard;*
- (3) The recommendation by an ATO shall be valid for 12 months; if the student/applicant has failed to attempt at least one theoretical knowledge examination within this period of validity, the need for further training shall be determined by the ATO, based on the needs of the student/applicant.*
